2018 Home Improvement Incentive Program

If you have a home ENERGY AUDIT and complete the recommended improvements, you can reduce energy consumption, lower your electric bill and may become eligible to receive rebates.

North Attleborough Electric Department (NAED) is offering our residential customers rebates on insulation upgrades, ENERGY STAR window and door/storm door replacements and central air units through the end of the year. * NAED encourages you to start saving energy by calling 888-772-4242 at to schedule an ENERGY AUDIT.

An audit must be conducted before you are eligible to receive a rebate.

When the energy conservation specialist conducts an ENERGY AUDIT of your home, you will receive valuable information on how to save energy right away.

As simple as A-B-C: Audits Before Cash

NAED's Home Improvement Incentive Program provides you with energy conservation information about your home. An ENERGY AUDIT of your home includes information on heating and hot water systems, shell insulation, appliances, windows, doors and lighting. An energy conservation specialist conducts the audit by walking through the home, demonstrating ways to save energy. After the audit, a computerized report is given to the homeowner recommending improvements that save energy. When some or all of the recommendations are done by the homeowner or a contractor, the customer completes the Application Form and submits it to NAED.

What kinds of projects qualify for incentives?

To qualify for a rebate, you must have an NAED account in good standing, the project must come from the recommendation made in the Energy Audit, and must be installed within the NAED service area before the end of the year*. The following insulation, window and door replacements and central air types are the only improvements that qualify for rebates:

*Attic, Basement, Wall, Rim Joint and Heating System Pipe Insulation
Energy Star Window Replacements-U Factor must be 0.35 or below
Energy Star Door/Storm Door replacement
Central Air Units*

*Total Cost of Project up to \$3,000: Rebate = 50%, maximum \$300
Total Cost of Project over \$3,000: Rebate = \$500*

Remember these simple steps:

- Contact NAED at 508-643-6310 to participate in the program
- Schedule an Energy Audit by calling 888-772-4242. An ENERGY AUDIT is required before work is completed.
- After the ENERGY AUDIT, complete the qualifying work between January 1, 2018 and December 31, 2018.
- Limit: ONE rebate per NAED customer.
- Complete the Home Improvement Incentive Application Form, attach sales receipts, contractor work orders and proof of payment. Submit by mail or dropping off to 275 Landry Avenue, North Attleborough, MA 02760. You may also scan and email to mdobson@naelectric.com.
- You will be called to schedule a POST installation inspection. NAED reserves the right to inspect the installation premises or otherwise verify installation of the project. Once inspection is completed a check will be issued.
- Please allow up to eight (8) weeks for processing.
