2019 Appliance Rebate Program

When you purchase an ENERGY STAR home appliance you can receive rebates, reduce energy consumption and help lower your electric bill.

What is ENERGY STAR?



ENERGY STAR is the symbol for energy efficiency, as designated by the U.S. Department of Energy (DOE) and the U.S. Environmental Protection Agency (EPA). The ENERGY STAR label helps consumers identify products that are more efficient than comparable models. The yellow ENERGY STAR EnergyGuide Label can be found on your appliances, computer equipment, photocopiers, home electronics, windows, doors and even on your house. Visit www.energystar.gov for more information on all the ENERGY STAR programs.

How do I qualify for rebates from NAED?

To qualify for a rebate, you must have an account with NAED in good standing, you must purchase a NEW appliance from the list below with the yellow ENERGY STAR Energy Guide Label, and it must be installed within the NAED service area before the end of the year.

Program Steps:

- When shopping for your new appliance look for the yellow ENERGY STAR label.
- Complete an NAED Rebate Application by either dropping by our office or the form can be found at www.naelectric.com.
- Submit your application along with the sales receipt (copies accepted) by mail to NAED Rebates c/o Energy New England, 100 Foxborough Blvd, Suite 110, Foxborough, MA 02035.
- Energy New England will validate the information and a check will be issued to qualified applicants. Please allow 6-8 weeks for processing.
- NAED reserves the right to inspect the installation premises or otherwise verify installation of the appliance.
- The rebate program begins on 1/1/2019 and ends on 12/31/2019, or when program funds are expended.
