2. Once the audit is completed, call NAED within 30 days to commit to do some or all the work listed on the Energy Management Audit Report.
3. Within 90 days of your commitment call to NAED, complete the work and install any new equipment at the service (account) address.
4. Fill out the application and attach all required documentation. When installation is inspected and approved, a rebate check will be issued within 4-6 weeks.

*NAED reserves the right to reject any application that is incomplete or does not meet program criteria. Each commercial customer is limited to a maximum rebate from the Power Saver Program of 80% up to \$2,000 per calendar year for Small General Service (CI-6) and \$5,000 per calendar year for Large General Service (CI-7). North Attleborough Electric Department (NAED) is offering business customers financial incentives to replace inefficient light fixtures and bulbs with energy savings products. Join the Power Saver Rebate Program by calling NAED for a FREE lighting audit valued up to \$1500!

We are offering rebates on a range of eligible lighting equipment for every kind of business. NAED will pay up to 80% of the installed upgrades based on the Energy Management Audit Report and your rate classification. Rate classifications are: General Service customers (Rate CI-6) who can receive up to \$2000 per calendar year or Large General Service customers (Rate CI-7; more than 40 kW per month), who can receive up to \$5,000 per calendar.

How does the program work?

To be eligible, your business must receive electric service from NAED and have an account in good standing. In order to qualify for a rebate, you must call NAED and schedule a lighting audit. Once the audit is completed, call NAED again within 30 days to commit to some or all the work listed on the Energy Management Audit Report. The work must be completed and the new equipment installed at the service (account) address within 90 days of your commitment call to NAED.

Once NAED has conducted a post-inspection and installation is approved, rebate check will be issued to you within 4-6 weeks.

What else should I know about the program?

There are a variety of lighting efficiency measures that qualify for a rebate from the Power Saver Rebate Program. Specific information on qualifying equipment will be provided to you in the Energy Management Audit Report.

The program starts January 1, 2018 and will run until December 31, 2018 or until program funds have been expended. Applications will be accepted on a first-come, first-served basis until allocated funds for the program are expended. Rebates are only available for the replacement or conversion of inefficient lighting equipment listed on the Energy Management Audit Report.

Program Eligibility Requirements:

1. Contact NAED at 508.643.6310 to schedule a Power Saver lighting audit.
2. After the audit is complete, again call NAED within 30 days to commit to do some or all the work listed on the Energy Management Audit Report.
3. Within 90 days of your commitment call to NAED, complete the work and install any new equipment at the service (account) address.
4. Fill out the Power Saver Program Rebate Application* and attach an original invoice for your equipment replacement. Both the business customer and contractor must sign each quotation. Rebates will only be paid upon presentation of valid original invoice and proof of payment.
5. NAED must conduct a post-inspection to certify that the installation meets program criteria.
6. A rebate check will be issued to qualified applicants with 4-6 weeks.
